On behalf of myself, members of my family, my heirs, executors, administrators, and assigns, I hereby forever release, discharge and hold harmless FIVESTAR BOXING ACADEMY, its representatives and agents, coaches, instructors, volunteers, or members of any injury, loss or damage to my person or property howsoever caused, arising out of or in connection with my taking part in Martial Arts, Cardio Classes, Self Defense Seminars, Weight Training, and activities/events hosted by FIVESTAR BOXING ACADEMY inside or outside of the base location. (This would include but is not limited to training outside, tournaments, Trade Shows, and off-site competitions).

### THE UNDERSIGNED ACKNOWLEDGES THAT:

1. He/She must inform instructors, coaches, and trainers of current or pre-existing medical conditions.
2. He/She is desirous of using, as a member on a membership basis, The Martial Arts School/Academy, herein referred to as "FIVESTAR BOXING ACADEMY."
3. He/She has received an entirely executed copy of this agreement.
4. He/She confirms that there will be no verbal presentations other than those specified in this agreement.
5. He/She may be photographed or filmed while attending at the premises of FIVESTAR BOXING ACADEMY, and he/she permits FIVESTAR BOXING ACADEMY and any affiliates to use any **photos, video footage and video streaming** for promotional, sales, publicity, and advertising purposes for all media including the internet.
6. Assumes all responsibility for any collection costs, including but not limited to reasonable collection agency fees, court costs, reasonable attorney's fees, and applicable late charges that may be incurred for default payments.
7. Failure to attend class does not signify or imply notification to cancel this agreement and will not be subject to a refund for unused sessions.
8. A student's failure to continue lessons during the notification or program period does not relieve the obligation to pay the remaining tuition balance in full.
9. **Membership cancellation** requires a minimum of Thirty (30) days written notice. The 30 days includes one additional month's payment (as one more would fall within the 30 days). Member will continue to have gym access for the remaining 30 days.
10. Option to **'freeze'** membership is available for **MEDICAL PURPOSES ONLY**.
11. Under NO circumstances shall the information, techniques or other skills learned at FIVESTAR BOXING ACADEMY be used outside the school unless required for self-defence. Failure to adhere to this condition may result in suspension or expulsion from the school without a refund.
12. FIVESTAR BOXING ACADEMY may modify the classes, schedule, curriculum, program and/or services offered as deemed necessary. Such modification does not relieve the undersigned of their obligations under any circumstances.
13. FIVESTAR BOXING ACADEMY may close the school on national holidays, for special events, and for a period not exceeding four (4) weeks per year for necessary maintenance and other purposes without affecting scheduled tuition payments.
14. By agreeing, the undersigned grants the facility permission to use photographs, video, artwork, or other likenesses of the student for marketing, trade, publishing, or any other lawful purpose.
15. Auto debit memberships are ongoing without expiration and will continue unless otherwise advised by 30 days' written notice. It is up to the payee to cancel the agreement. For **limited-time memberships**, an expiration notification will be given. At this point, new paperwork may be required for membership renewals.
16. Health and safety are our number one concern here at FIVESTAR BOXING ACADEMY. Understand that for the continued health and safety of all our members, the undersigned agrees to keep their equipment and persons clean and hygienic. Use proper equipment as advised by coaches in all respective sports. Coaches **MUST** be notified of health issues that may affect themselves and other members (communicable disease, serious illness, pregnancy, etc.)
